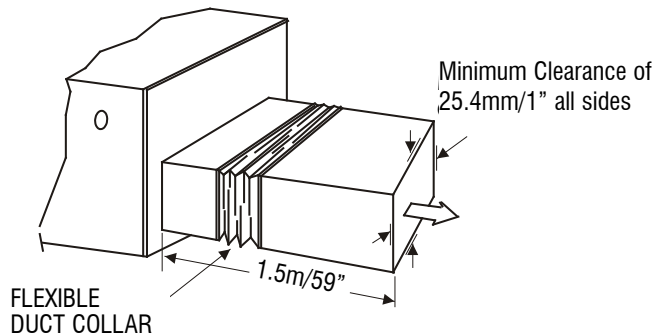


Vertical Installations

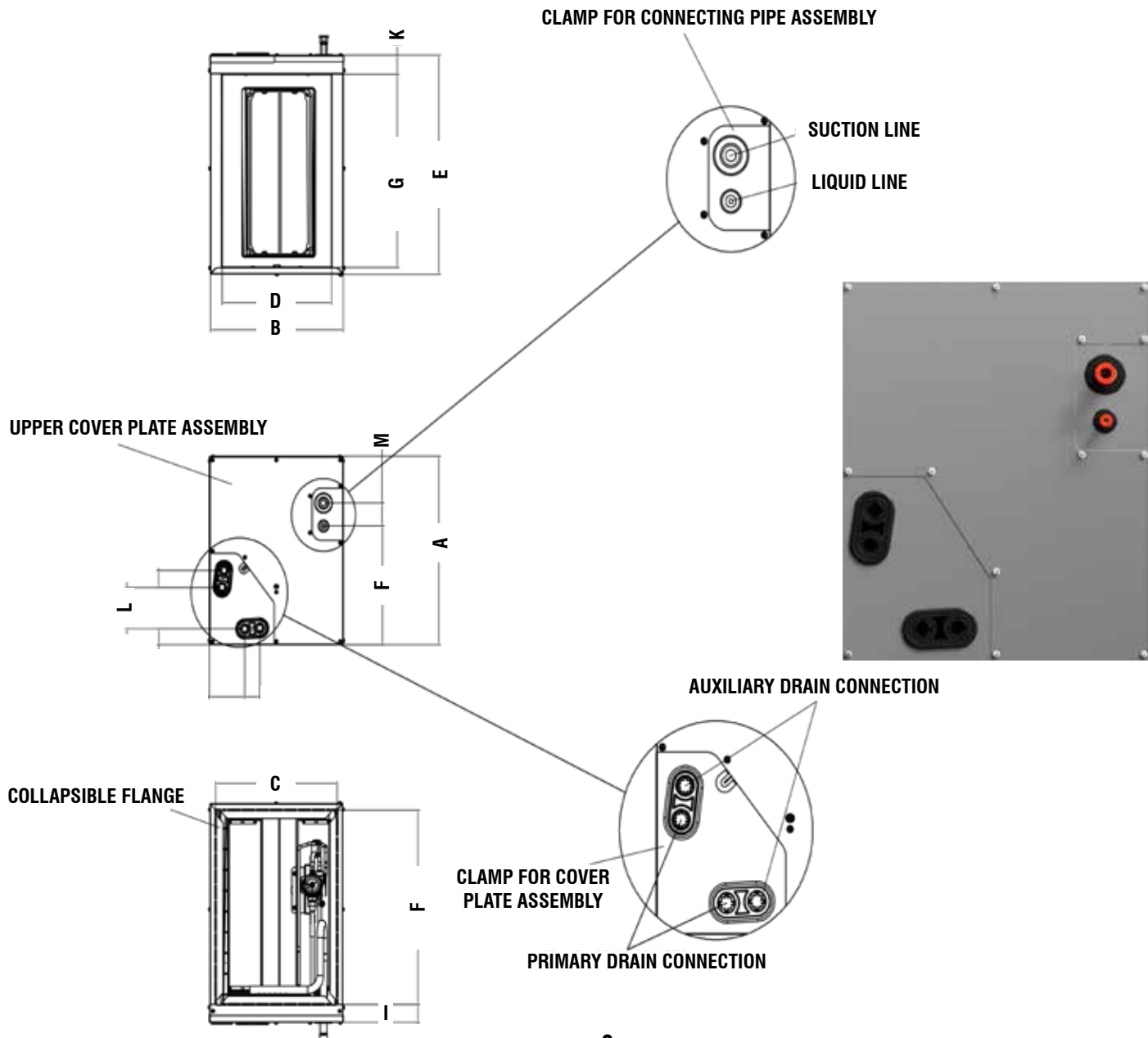

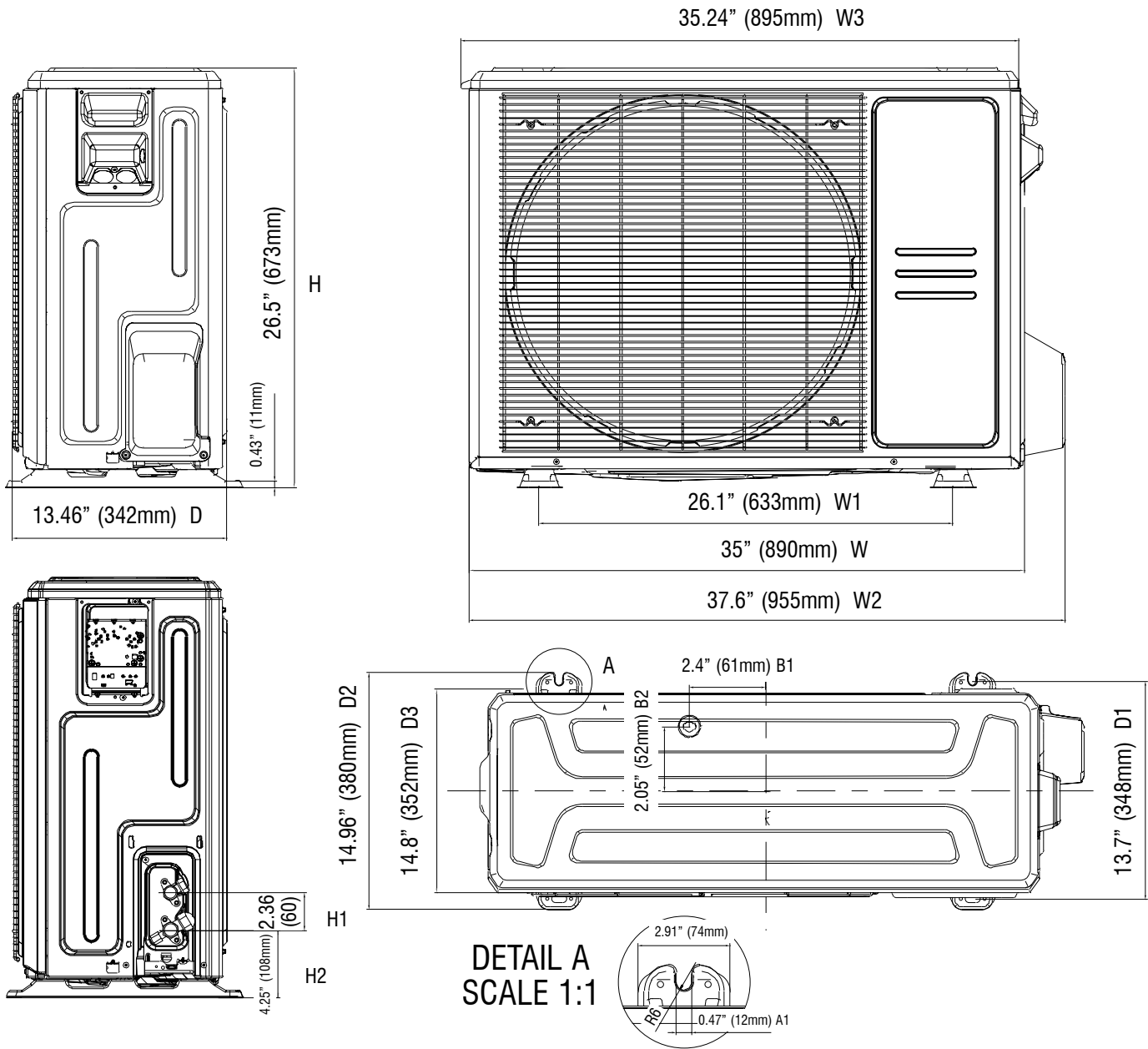

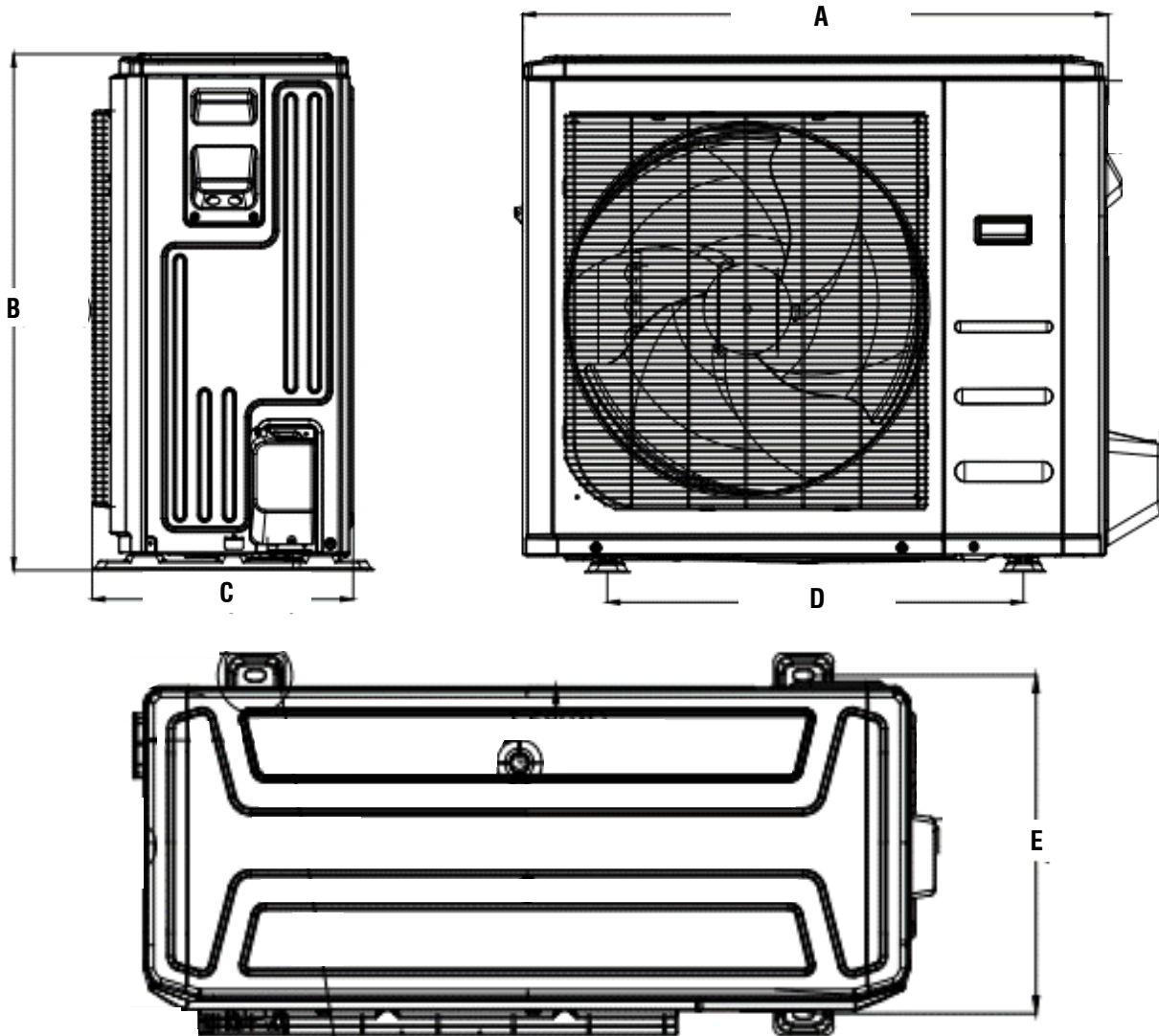
Outdoor Unit Dimensions - 18K & 24K

Outdoor Unit Dimensions - 30, 36, & 48K

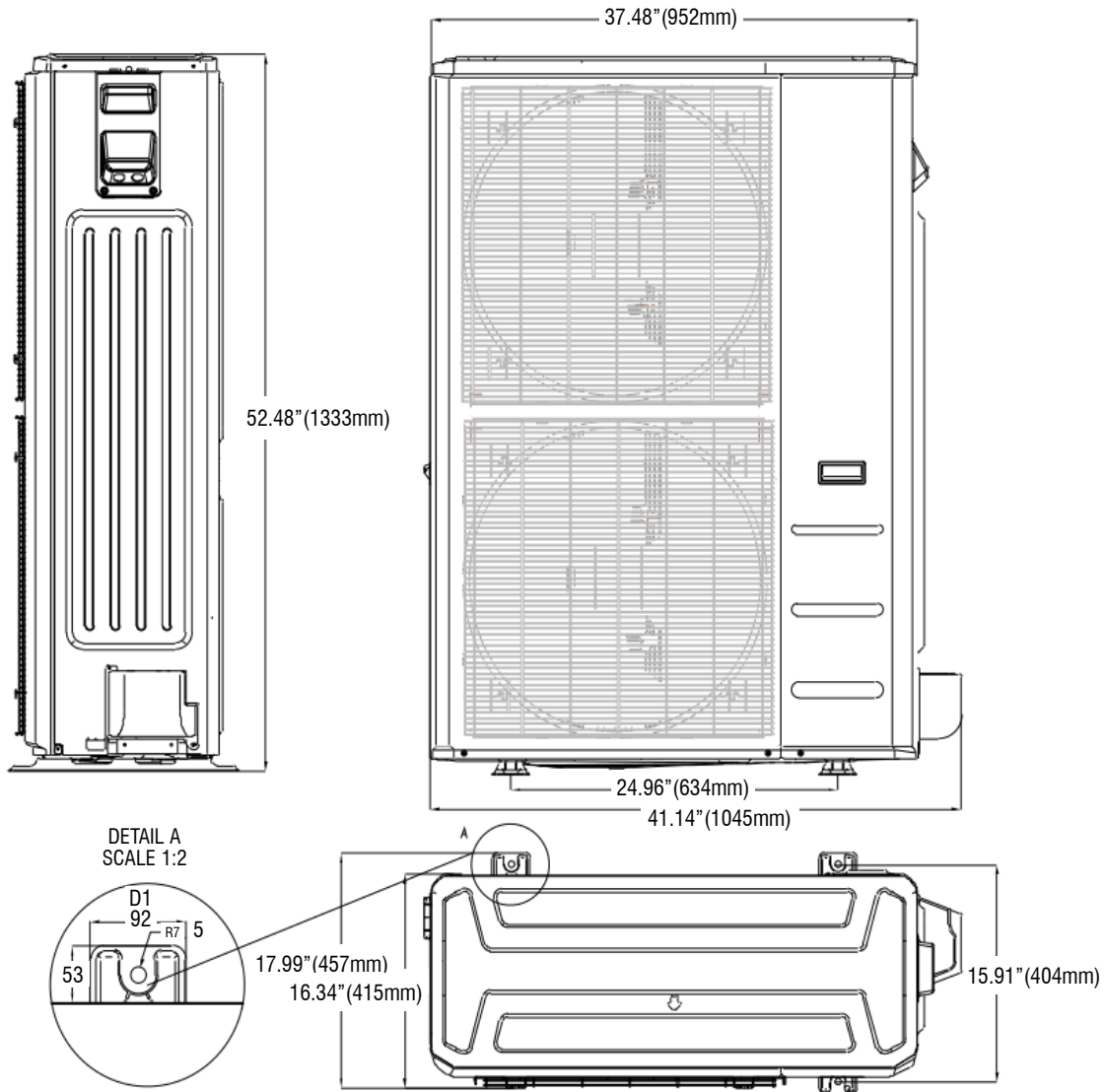
